STATUTORY INSTRUMENT, 2021, No. 25

[1st February, 2021]

In exercise of the power conferred under section 16 of the COVID-19 (Prevention and Control) Act, No. 9 of 2020, the Minister responsible for health, makes this Order:

Citation and commencement

1. This Order may be cited as the COVID-19 (Prevention and Control) (Prohibition of Assembly) (No. 1) (Amendment) Order, 2021.

Replacement of section 3

2. The COVID-19 (Prevention and Control) (Prohibition of Assembly) (No. 1) Order, No. 11 of 2021 is amended by deleting section 3 and replacing wth the following -

"Expiry

3. This Order expires on the 10th day of February, 2021.

STATUTORY INSTRUMENT, 2021, No. 26

[1st February, 2021]

In exercise of the power conferred under section 17 of the COVID-19 (Prevention and Control) Act, No. 9 of 2020, the Minister responsible for health, makes this Order:

Citation

1. This Order may be cited as the COVID-19 (Prevention and Control) (Physical Distancing) (No. 1) (Amendment) (No. 3) Order, 2021.

Interpretation

2. In this Order, "principal Order" means the COVID-19 (Prevention and Control) (Physical Distancing) (No. 1) Order, Statutory Instrument, No. 12 of 2021.

Amendment of section 5

3. Section 5 of the principal Order is amended by —

- (a) in subsection (1), deleting paragraph (b) and replacing with the following
 - "(b) shall cease operation at 7 p.m to 5 a.m. on each day commencing from the 3rd day of February, 2021.";
- (b) deleting subsection (2) and replacing with the following —

"(2) Subsection (1) does not apply to -

- (a) a local fisherman under regulation 3(2) of the COVID-19 (Prevention and Control) (Protocol) (Fishing) Regulations, Statutory Instrument, No. 172 of 2020;
- (b) an essential service, a business, an establishment or an office specified in Schedule 2.".

Amendment of section 7

4. Section 7 of the principal Order is amended by deleting subsection (1) and replacing with the following -

"(1) Sections 2, 3, 4 and 5 expire on the 10^{th} day of February, 2021.".
